DELEGATION OF POWERS, DUTIES AND FUNCTIONS OF MINISTER UNDER MGA  
TO THE KANANASKIS IMPROVEMENT DISTRICT COUNCIL

I, Ty Lund, Minister of Environmental Protection, pursuant to sections 586, 587 and 589 of the *Municipal Government Act*, make the following order:

1. Subject to sections 2 and 3 of this Order, the *Municipal Government Act* applies to Kananaskis Improvement District as if it were a municipality, except as otherwise stated in this Order or in any existing or future Order affecting Kananaskis Improvement District.
2. Those sections of the *Municipal Government Act* listed in the attached Schedule A do not apply to Kananaskis Improvement District.
3. Those sections of the *Municipal Government Act* listed in the attached Schedule B apply, as modified, to Kananaskis Improvement District.

4. Subject to this Order, the Kananaskis Improvement District Council has the powers, duties and functions of the Minister as a municipal council emanating from the *Municipal Government Act*, as it relates to the Kananaskis Improvement District.

6, 11	<p>Natural person powers: This provision applies except where an obligation or duty is undertaken that extends beyond six months, no action shall be taken without the Minister's prior approval. Kananaskis Improvement District shall be responsible for providing the following municipal services:</p> <ul style="list-style-type: none"><li>Municipal Administration</li><li>Disaster and Emergency Measures</li><li>Fire Protection</li><li>Ambulance</li><li>Street Lighting</li><li>Waste Management</li><li>Waste Water Treatment and Disposal</li><li>Water Supply and Distribution</li><li>Weed Control</li><li>Public Health and Welfare</li></ul>
162	<p>Vacancy in position of councillor. This provision applies, subject to Orders under section 588.</p>
167	<p>Quorum provision applies as and when modified by a specific Order of the Minister made applicable to an improvement district.</p>
Part 5, Division 8	<p>Enforcement of disqualification applies except where reference is made to the Court, it shall be deemed to refer to the Minister of Environmental Protection.</p>
203	<p>Delegation by council: This provision applies as and when modified by a specific Order of the Minister made applicable to Kananaskis Improvement District.</p>
